

Chance to win a 'Basket of Chocolate Easter Eggs' Competition Terms and Conditions

- 1. The "Basket of Easter Eggs social media competition" competition (**Competition**) is a competition run by Frasers Property Limited (ABN 12 008443696) (**Frasers Property**) and East Baldivis Nominees Pty Ltd (ABN 49 167 317 204) on and subject to these terms and conditions.
- 2. To be eligible to enter the Competition, you must be 18 years of age or over (Eligible Participant).
- 3. To enter the Competition (Entry), an Eligible Participant must:
 - a) Make a comment on the Facebook post for the Competition in respect of the relevant Eligible Project describing how many Easter eggs the entrant thinks are contained within the basket. The closest guess to the actual number of chocolate Easter eggs will be deemed the winner, determined in accordance with paragraph 7 of these Terms and Conditions.
- 4. The Competition commences at 9.00am (WST) on Friday 1 April 2022 and ends at 4.00pm (WST) on Tuesday 12 April 2022 (**Promotion Period**).
- 5. An Eligible Participant can only submit one Entry. An Entry is deemed to be received at the time that Frasers Property receives notice that the Eligible Participant has complied with clause 3 of these Terms and Conditions and not at the time that the Eligible Participant complies with that clause. Entries must be received by Frasers Property during the Promotion Period. Entries received by Frasers Property after the Promotion Period will automatically be deemed as invalid.
- 6. The total prize pool of the Competition consists of one 'Basket of Chocolate Easter Eggs' (valued at \$75) to be awarded to the winner determined in accordance with paragraph 7 of these Terms and Conditions.
- 7. Authorised representatives of Frasers Property will select the Entry closest to the actual number of eggs by an Eligible Participant for the Eligible Project as the winner. The winner will be announced on Facebook in the comments section of the post on the Eligible Project Facebook page by Wednesday 13 April 2022. The winner will also be notified by Facebook direct message with details on how to redeem their prize. If multiple Entries of the same closest number are received, authorised representatives of Frasers Property will select a winner based on who posted correctly first.
- 8. The winner will also be contacted and notified directly by Frasers Property with details on how to collect their prize.
- 9. The Competition is a game of chance and skill plays no part in determining the winner. Frasers Property's decision is final, and no correspondence will be entered into in relation to any dispute or other matter arising in relation to the Competition. Eligible Participants acknowledge that the Competition is in no way sponsored, endorsed or administered by, or associated with Facebook. Eligible Participants must follow and act in accordance with the Facebook Statement of Rights and Responsibilities.
- 10. Each Eligible Participant consents to Frasers Property using his or her name and their Competition entry in any media for promotional purposes related to the Competition. Each winner agrees to participate and co-operate as required by Frasers Property in promotional activities relating to the Competition.

Frasers Property accepts no responsibility for any late, lost, incomplete, misdirected, incorrectly submitted, delayed or ineligible entries, applications, claims or correspondence whether due to error, omission, alteration, tampering, theft, deletion, destruction, transmission, interruption, communications failure or otherwise.
