

Chance to win a Fishing Kayak Competition Terms and Conditions

- 1. The "Frasers Landing Win a Fishing Kayak" competition (**Competition**) is a competition run by Frasers Mandurah Pty Limited (ABN 47 112 832 523) (**Frasers Property**) on and subject to these terms and conditions.
- 2. To be eligible to enter the Competition, you must be 18 years of age or over (**Eligible Participant**). Employees and agents of Frasers Property Australia, or relatives of them, and any related bodies, are not eligible to enter the Competition and if such an entry is submitted, it will not be valid.
- 3. To enter the Competition (**Entry**), an Eligible Participant must complete an entry form on the Ipad, or fill out an official, printed entry form and place in the barrel, both are located in the Frasers Landing Sales Centre at 1 Landings Boulevard, Coodanup WA 6210 before 5.00pm Thursday 28 February 2019.

Prizes must be claimed at the time of notification, or as otherwise specified by the Promoter.
- 8. If a prize is unclaimed, the Promoter reserves the right to re-award the prize in accordance with these Conditions of Entry.

Frasers Property's decision is final and no correspondence will be entered into in relation to any dispute or other matter arising in relation to the Competition.
