

Chance to win a 'Voucher to Flics Kitchen' Competition Terms and Conditions

- The "Voucher to Flics Kitchen social media competition" competition (Competition) is a competition run by Frasers Property Limited (ABN 12 008443696) (Frasers Property) and Frasers Mandurah Pty Ltd (ABN 47 112 832 523) on and subject to these terms and conditions.
- 2. To be eligible to enter the Competition, you must be 18 years of age or over (Eligible Participant).
- 3. To enter the Competition (Entry), an Eligible Participant must:

The winner will also be notified by Facebook direct message with details on how to redeem their prize.
