

Chance to win a 'Voucher to Flics Kitchen' Competition Terms and Conditions

1. The "Voucher to Flics Kitchen social media competition" competition (**Competition**) is a competition run by Frasers Property Limited (ABN 12 008443696) (**Frasers Property**) and Frasers Mandurah Pty Ltd (ABN 47 112 832 523) on and subject to these terms and conditions.
2. To be eligible to enter the Competition, you must be 18 years of age or over (**Eligible Participant**).
3. To enter the Competition (**Entry**), an Eligible Participant must:
 - a) Like the relevant competition post and share a comment on the post describing the 'Biggest present fail or success on Mother's Day' determined in accordance with paragraph 7 of these Terms and Conditions.

An Entry is deemed to be received at the time that Frasers Property receives notice that the Eligible Participant has complied with clause 3 of these Terms and Conditions and not at the time that the Eligible Participant complies with that clause. Entries must be received by Frasers Property during the Promotion Period. Entries received by Frasers Property after the Promotion Period will automatically be deemed as invalid.

The winner will also be notified by Facebook direct message with details on how to redeem their prize.

Frasers Property's decision is final, and no correspondence will be entered into in relation to any dispute or other matter arising in relation to the Competition.
