

Chance to win a '\$100 voucher for Coogee Common' Mother's Day Competition Terms and Conditions

1. The "\$100 voucher for Coogee Common' Mother's Day social media competition" (**Competition**) is a competition run by Port Catherine Developments Pty Ltd (ACN 070 096 927) (**Frasers Property**) on and subject to these terms and conditions.
2. To be eligible to enter the Competition, you must be 18 years of age or over (**Eligible Participant**).
3. To enter the Competition (**Entry**), an Eligible Participant must:
 - a) Make a comment on the Facebook post for the Competition in respect of the relevant Eligible Project describing "the one thing your mother does that no other would do". This can be written in the comments section of the post.
4. The Competition commences at 9.00am (AWST) on 30 April 2022 and ends at 4.00pm (AWST) on 6 May 2022 (**Promotion Period**).
5. An Eligible Participant can only submit one Entry. An Entry is deemed to be received at the time that Frasers Property receives notice that the Eligible Participant has complied with clause 3 of these Terms and Conditions and not at the time that the Eligible Participant complies with that clause. Entries must be received by Frasers Property during the Promotion Period. Entries received by Frasers Property after the Promotion Period will automatically be deemed as invalid.
6. The total prize pool of the Competition consists of one '\$100 voucher for Coogee Common' (valued at \$100) to be awarded to the winner determined in accordance with paragraph 7 of these Terms and Conditions.
7. Authorised representatives of Frasers Property will select their favourite Entry by an Eligible Participant for the Eligible Project as the winner. The winner for the prize will be announced on Facebook in the comments section of the post on the Eligible Project Facebook page on 6 May 2022 after 4.00pm (AWST).
8. The winner will be contacted and notified directly by Frasers Property with details on how to collect their prize.
