

Chance to win a '\$100 voucher for Coogee Common' Mother's Day Competition Terms and Conditions

- 1. The "\$100 voucher for Coogee Common' Mother's Day social media competition" (**Competition**) is a competition run by Port Catherine Developments Pty Ltd (ACN 070 096 927) (**Frasers Property**) on and subject to these terms and conditions.
- 2. To be eligible to enter the Competition, you must be 18 years of age or over (Eligible Participant).
- 3. To enter the Competition (Entry), an Eligible Participant must:
 - a) Make a comment on the Facebook post for the Competition in respect of the relevant Eligible Project describing "the one thing your mother does that no other would do". This can be written in the comments section of the post.
- 4. The Competition commences at 9.00am (AWST) on 30 April 2022 and ends at 4.00pm (AWST) on 6 May 2022 (**Promotion Period**).
- 5. An Eligible Participant can only submit one Entry. An Entry is deemed to be received at the time that Frasers Property receives notice that the Eligible Participant has complied with clause 3 of these Terms and Conditions and not at the time that the Eligible Participant complies with that clause. Entries must be received by Frasers Property during the Promotion Period. Entries received by Frasers Property after the Promotion Period will automatically be deemed as invalid.
