## THE FIRST HOME OWNER GRANT EXPLAINED

### A FIRST HOME OWNER'S GUIDE TO CLEARING THE FHOG (FIRST HOME OWNER GRANT)

#### So what's the deal with the FHOG? What does it mean for you?

The WA State Government's \$10,000 First Home Owner Grant is available for all eligible construction contracts, or contracts for the purchase of a new apartment. This means that if you meet the eligibility criteria, you could use that \$10,000 towards building a brand new house on vacant land, or on a brand new apartment, even if it's off the plan.

## BUT WAIT, THERE'S MORE!

Take advantage of some additional incentives!

- No Stamp Duty when buying a new home or apartment under \$430,000
- Buy from a licensed real estate agent and you may be eligible for up to another \$2,000
- Changes to the WA State Government's Keystart Programme make it even easier to qualify for a low deposit home loan.

# HOW TO GET STARTED

There are a few things you need to know before you start applying for the FHOG. **A good place to begin is <u>firsthome.gov.au</u>** 

Click through to the WA page, go to 'About the First Home Owner Grant', and you'll find a host of helpful information that will guide you through the steps.

Find out if you are eligible

Answer a few simple questions and you're on your way.

- Fill out the forms
  Go to <u>'Your Application</u>'. You'll see the link to the form you need, F-FHOG1.
- **3.** Make sure you have the correct documentation

Check the list to see you have all the supporting documents required, found under <u>'Your Application'</u>.

Free stamp duty
 Available for a new home or apartment under \$430,000, click on <u>'Payment and Rate of Duty'</u> to see if you qualify.

 Submit the forms
 Applications may be submitted through a FHOG approved agent or directly to the Office of State Revenue – details are under <u>'Your Application - How do I apply?'</u> There is also the opportunity to track your application.
