

## **Q** For Body and Soul Event Day Competition Terms and Conditions

- 1. This competition commences at 10:00:00 WST on Sunday 27 November 2016 and closes at 14:00:00 WST on Sunday 27 November 2016 ("Promotional Period"). Taking part in this competition constitutes acceptance of these terms and conditions.
- 2. The promoter of the competition is Frasers Property Australia Pty Limited ACN 600 448 726 ("Promoter").
- 3. Information on how to enter and prizes form part of these Conditions of Entry. Entry into this promotion is deemed acceptance of these Conditions of entry by each entrant.
- 4. Entry is open to Western Australian residents 18 years of age and over and who hold a valid email account ("Eligible Entrants").
